### Objective

A global growth strategy which aims to maximise long-term investment returns by harnessing global equity investment opportunities. The managers invest in overseas equity funds and in the UK equity market. The managers will adjust the asset allocation from time to time depending upon market circumstances, but not to an extent that would significantly alter the long-term risk-return profile of the investment strategy. The portfolio combines active fund managers, who aim to outperform their benchmarks (after costs), and passive investments, which offer cost-effective market exposure. The aim is to achieve better returns than the underlying markets while controlling the overall cost of the investment.

### Suitability

This portfolio may be suitable for clients with an extended investment time horizon or significant previous investment experience. They are seeking an investment providing unconstrained return opportunities while, through its wider diversification, preventing the total loss risk of single-stock investments.

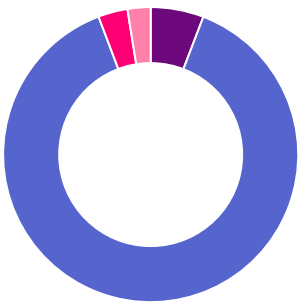

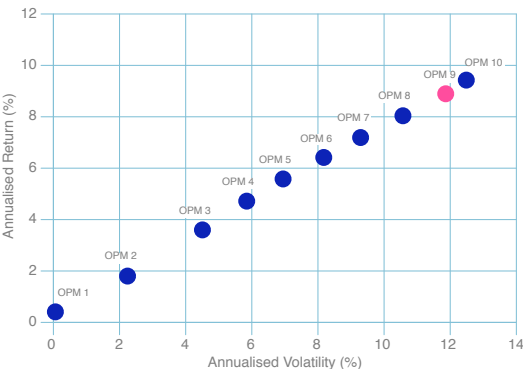
